Executive (National Nonprofit)

E.g.: Nonprofit and youth-serving, national youth sports organizations, national sport governing bodies. This voting membership entitles the organization to be represented by one individual. Executive membership does not include subordinate organizations.

Allied (Corporate For-Profit)

This membership is available to any one person engaged in selling, marketing and promoting products and/or services of interest to NCYS members and/or their organization. E.G.: For-profit corporations, sporting goods manufacturers, fundraisers, service providers.

Associate (Local, State or Regional Chapters & Organizations)

This membership is available to any one person in a nonprofit and youth-serving local, state or regional chapters of national organization such as NCYS local chapters, parks & recreation departments, CYO's, JCC's, local community leagues, etc. This membership is only available to those who do not qualify for executive or allied membership.

Associate2 (CVB's, Sports Commissions)

This membership is only available to those who do not qualify for executive, allied, or associate membership.
